Summer Construction

Corner Construction. Renew Opelika Road. South College Street. There's a lot going on this summer. Here's your guide to construction underway and forthcoming.

Corner Construction

The Corner Construction project is a historic opportunity to recreate the Toomer's Corner intersection for the 21st century. Toomer's Corner changed forever when the original Auburn Oaks were poisoned. With the removal of the Oaks, Auburn University undertook an improvement project to renovate the corner before the new trees were installed.

Now, with aging water and sewer infrastructure in need of replacement under the intersection, the City of Auburn has committed to renovation of the rest of the Toomer's Corner. The city has worked closely with Auburn University so that the end result of both projects will have a similar look and feel. The city has also solicited significant public input for the Corner Construction project through the Downtown Master Plan public meeting process.

Bailey-Harris Construction Company is now hard at work on the Corner Construction, with plans to have the intersection re-opened to traffic as early as possible in August, but no later than August 17. While the corner is closed, downtown businesses, shops and restaurants are open for business. Free parking is available on all three levels of the Municipal Parking Deck on Gay Street, in the Gay Street parking lot and on street on Gay Street, Magnolia Avenue, College Street, Tichenor Avenue and Wright Street. As this Open Line is being written, the alleyway improvements project is still underway for the Magnolia Avenue and College Street alleyways connecting downtown business with the parking deck and Gay Street parking lot. As with the Corner Construction, this project allows the city to replace decades-old water, sewer and stormwater infrastructure underground while making significant improvements to lighting, walkability and the sense of safety for downtown pedestrians. Alleyway improvements are scheduled to be complete in July.



Downtown

North of the Corner Construction, improvements will be made on North College near the train tracks and on Mitcham Avenue near the old Train Depot. As the Depot's new owners work to open a new restaurant for the fall, the city will improve the streetscape on Mitcham to improve conditions for increased pedestrian traffic in the area. The work will also tie downtown improvements in with the Renew Opelika Road project underway at and near the intersection of Gay Street and Opelika Road.

Renew Opelika Road

The Renew Opelika Road plan will guide the future development and redevelopment of one of Auburn's most important commercial corridors. Auburn residents provided input for the Renew

Opelika Road plan during a series of public meetings that took place as the plan was being developed.

Implementation of the Renew Opelika Road plan is currently underway, with construction work affecting Opelika Road from Gay Street to Ross Street. This phase of the project includes new sidewalks along Opelika Road, new landscaping along the street and new medians on Opelika Road.

On the other end of Opelika Road, near the Auburn Mall, construction crews are at work improving the intersection of East University Drive (EUD) and Opelika Road. This intersection improvement project consists of widening Opelika Road and East University Drive to add dual left turn lanes on both sides of Opelika Road and southbound on East University Drive as well as landscaping and pedestrian improvements in the rights of way.

When you pass through the Opelika Road/EUD area, you may also notice construction activity related to the demolition and reconstruction of the old K-Mart property. That property is under new ownership with plans to bring new grocery and retail opportunities to this vital commercial location.



South College Street

The City of Auburn is currently working on a project to improve traffic flow at the intersection of South College Street and Longleaf Avenue. As those improvements are completed, the Alabama Department of Transportation has scheduled South College Street to be resurfaced from the Interstate to Shug Jordan Parkway/East University Drive.

Upcoming

Upcoming projects include:

- A new traffic signal at the intersection of Opelika Road and Commerce Drive at the City limits. This is a joint project with the City of Opelika
- A new traffic signal at the intersection of Cox Road and Longleaf Drive
- Woodfield Drive Resurfacing and Traffic Light Replacement
- Gay Street Resurfacing from Reese Avenue to Camellia Drive
- Donahue Drive Resurfacing from Cary Drive to Shug Jordan Parkway
- Wire Road Widening and Turn Lanes
- Moores Mill Bridge Replacement
- Duck Samford Parking Lot resurfacing

Water Works Board Consumer Confidence Report

Each year, the Water Works Board of the City of Auburn (AWWB) distributes its annual Consumer Confidence Report (CCR). The purpose of this report is to inform all water customers about contaminants that may be found in their drinking water and how these contaminants may affect their health. The CCR is also an opportunity to educate customers about drinking water sources, treatment techniques and delivery methods used to ensure compliance with State and Federal laws.

Water Quality Monitoring Public Viewer

The Watershed Division and the GIS Division of the City of Auburn are proud to announce the release of the City's Water Quality Monitoring Public Viewer Application. This web-based application allows the public to view water quality data from forty (40) monitoring locations on streams throughout the city. These stations are monitored weekly by Watershed Division staff using modern water quality monitoring equipment.

Although no single measure reported in the app gives a complete picture of "quality" of water in our local streams, and other water resources, these data help water resource managers better understand the general physical-chemical conditions of our waters, identify potential causes for concern and help to select and prioritize management strategies and protective measures. This application also helps provide transparency in our monitoring operations by providing an additional tool for citizens to become aware and involved in helping to preserve and protect our local water resources. City Hosts ADA Conference

On April 27 and 28, the City of Auburn hosted the 2015 Auburn Accessibility Conference in partnership with the Auburn University Office of AA/EEOC/ADA and the Auburn Chamber of Commerce. This event, held at the Auburn University Hotel and Conference Center, featured instructors and speakers from the United States Access Board and the Governor's Office of Accessibility. The conference was attended by 116 participants, including over 50 attendees from surrounding jurisdictions and other states. The conference materials were designed to provide participants with a better understanding of the design and construction requirements under the Americans with Disabilities Act and its amendments and guidelines.

The event was also a very cost effective way to provide appropriate city staff with needed additional training. Through collaboration with the Auburn University College of Architecture and the Southeast Alabama Codes Officials Association, the event was approved for continuing education units (CEUs) for many professional staff, allowing the training opportunity to be used to meet annual licensing and recertification requirements without additional expense to the city.

The city has received very positive feedback from both the participants and the speakers, many of whom remarked about not only the quality of the event, but the level of understanding of ADA requirements exhibited by the participants. The city sponsored the event to help local design professionals have the knowledge they need to comply with Federal ADA regulations as they provide services to local businesses and residents.
